The Courts Service, in exercise of the powers conferred on it by section 26 of the Courts of Justice Act 1953 (No. 32 of 1953), as amended by section 43 of the Courts (Supplemental Provisions) Act 1961 (No. 39 of 1961), section 16 of the Courts Act 1971 (No. 36 of 1971) and section 29 of the Courts Service Act 1998 (No. 8 of 1998) and after consultation with the President of the District Court, hereby orders as follows:

1. This Order may be cited as the District Court Districts and Areas (Amendment) and Variation of Days for the District Court Area of Cork City Order, 2024

This Order shall come into operation on 2<sup>nd</sup> of April 2024

2. The First Schedule to the District Court (Areas) Order, 1961 ( S.I. No. 5 of 1961 ), is hereby amended by—

the substitution at reference number 39 for the matter in column (4) of the following:

“Each Monday, Tuesday, Wednesday, Thursday and Friday each month. All sittings at 10.30 a.m.”

3. The Second Schedule to the District Court (Areas) Order, 1961 (S.I. No. 5 of 1961), is hereby amended by—

the substitution at reference number 34 for the matter in column (4) of the following:

Each Monday, Tuesday, Wednesday and Thursday each month. All sittings at 10.30 a.m.”

4. Business transacted in the District Court that is initiated and not completed before commencement of this Order shall be continued and completed as if this

Order had been in force at the time at which such business had been initiated.
