## CREDIT UNION (AMENDMENT) ACT 2023 (COMMENCEMENT OF CERTAIN PROVISIONS) ORDER 2024

I, MICHAEL MCGRATH, Minister for Finance, in exercise of the powers conferred on me by section 1 (2) of the Credit Union (Amendment) Act 2023 (No. 34 of 2023), hereby order as follows:
