2. The 16th day of May 2007 is appointed as the day on which sections 28, 29 and 30 of the Civil Service Regulation (Amendment) Act 2005 (No. 18 of 2005) shall come into operation.

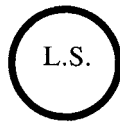
