COUNTY OF KILDARE LOCAL ELECTORAL AREAS ORDER 2008

The Minister for the Environment, Heritage and Local Government, in exercise of the powers conferred on him by sections 3 and 24 of the Local Government Act 1994 (No. 8 of 1994), hereby orders as follows:

1. This order may be cited as the County of Kildare Local Electoral Areas Order 2008.

2. (1) The County of Kildare shall be divided into the local electoral areas which are named in the first column of the Schedule to this Order.

(2) Each such local electoral area shall consist of the area described in the second column of the Schedule to this Order opposite the name of such local electoral area.

(3) The number of members of Kildare County Council to be elected for each such local electoral area shall be the number set out in the third column of the Schedule to this Order opposite the name of that local electoral area.

3. Every reference in the Schedule to this Order to an electoral division, town or townland shall be construed as referring to such electoral division, town or townland as existing at the date of this Order and every reference to a former rural district shall be construed as a reference to that district as constituted immediately before the 1st day of October 1925.

4. A reference in the Schedule to this Order to a line drawn along a motorway shall be construed as a reference to an imaginary line drawn along the central median of such motorway.

5. The County of Kildare Local Electoral Areas Order 1998 (S.I. No. 336 of 1998) is hereby revoked.
