AGRICULTURE, FISHERIES AND FOOD (DELEGATION OF
MINISTERIAL FUNCTIONS) ORDER 2009

The Government, on the request of the Minister for Agriculture, Fisheries and Food and in exercise of the powers conferred on them by section 2(1) of the Ministers and Secretaries (Amendment) (No. 2) Act 1977 (No. 28 of 1977), hereby order as follows—

1. This Order may be cited as the Agriculture, Fisheries and Food (Delegation of Ministerial Functions) Order 2009.

2. The powers (other than the power to prosecute an offence) and duties of the Minister for Agriculture, Fisheries and Food conferred on him—

(a) by or under the enactments specified in Part 1 of the Schedule, and

(b) under the Regulations made under section 3 of the European Communities Act 1972 (No. 27 of 1972) specified in Part 2 of the Schedule,

are delegated to Tony Killeen, Minister of State at the Department of Agriculture, Fisheries and Food.

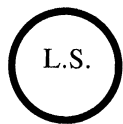
