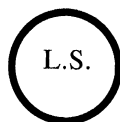
EUROPEAN COMMUNITIES (OFFICIAL CONTROLS ON THE
IMPORT OF FOOD OF NON-ANIMAL ORIGIN FOR PESTICIDE
RESIDUES) (AMENDMENT) REGULATIONS 2011.

I, SIMON COVENEY, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving full effect to Commission Implementing Regulation (EU) No.799/2011 of 9 August 2011¹, hereby make the following regulations:

1. These Regulations may be cited as the European Communities (Official Controls on the Import of Food of Non-Animal Origin for Pesticide Residues) (Amendment) Regulations 2011.

2. The European Communities (Official Controls on the Import of Food of Non-Animal Origin for Pesticide Residues) Regulations 2011 (S.I. No.426 of 2011) are amended by substituting in Regulation 2(1) the definition of “Commission Regulation 669/2009” for the following—

“ ‘Commission Regulation 669/2009’ means Commission Regulation (EC) No. 669/2009 of 24 July 2009 as amended by Commission Regulation (EU) No. 212/2010 of 12 March 2010, Commission Implementing Regulation (EU) No 433/2011 of 4 May 2011 and Commission Implementing Regulation (EU) No. 799/2011 of 9 August 2011;”.

These regulations revise controls on the import of certain food of non-animal origin from specific third countries with regard to pesticide residues.
