I, SIMON COVENEY, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Implementing Directive 2012/44/EU of 26 November 2012¹, hereby make the following regulations:

1. These Regulations may be cited as the European Communities (Minimum Conditions for Examining Vegetable Species) (Amendment) Regulations 2013.

2. The European Communities (Minimum Conditions for Examining Vegetable Species) Regulations 2004 (S.I. No. 121 of 2004) are amended by substituting in Regulation 2 the definition of “Directive” for the following:

“ ‘Directive’ means Commission Directive No. 2003/91/EC of 6 October 2003² as amended by Commission Directive No. 2012/44/EU of 26 November 2012.”.

3. The European Communities (Minimum Conditions for Examining Vegetable Species) (Amendment) Regulations 2011 (S.I. No. 736 of 2011) is revoked.
