FOOD HYGIENE (REVOCATION OF VARIOUS ORDERS) ORDER 2013

- I, JAMES REILLY, Minister for Health, in exercise of the powers conferred on me by Regulations 2, 35 and 55 of the Food Hygiene Regulations, 1950 (S.I. No. 205 of 1950) (as adapted by the Agriculture, Fisheries and Food (Alteration of Name of Department and Title of Minister) Order 2011 (S.I. No. 455 of 2011)), after consultation with the Minister for Agriculture, Food and the Marine, hereby make the following regulations:
- 1. This Order may be cited as the Food Hygiene (Revocation of Various Orders) Order 2013.
