EUROPEAN UNION (END-OF-LIFE VEHICLES) (AMENDMENT)  
REGULATIONS 2020

I, RICHARD BRUTON, Minister for Communications, Climate Action and Environment, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) and for the purpose of giving further effect to Directive 2000/53/EC<sup>1</sup> of the European Union and of the Council of 18 September 2000, as amended, hereby make the following regulations:

1. These Regulations may be cited as the European Union (End-of-Life Vehicles) (Amendment) Regulations 2020.

2. The European Union (End-of-Life Vehicles) Regulations 2014 (S.I. No 281 of 2014) are amended by substituting the following definition:

“the Directive’ means the European Parliament and Council Directive 2000/53/EC of 18 September 2000 on end-of-life vehicles as amended by Commission Decision 2002/525/EC<sup>2</sup> of 27 June 2002 and Commission Decision 2005/438/EC<sup>3</sup> of 10 June 2005 and Council Decision 2005/673/EC<sup>4</sup> of 20 September 2005 and Council Directive 2008/33/EC<sup>5</sup> of 11 March 2008 and Commission Decision 2008/689/EC<sup>6</sup> of 1 August 2008 and Council Directive 2008/112/EC<sup>7</sup> of 16 December 2008 and Commission Decision 2010/115/EU<sup>8</sup> of 23 February 2010 and Commission Directive 2011/37/EU<sup>9</sup> of 30 March 2011 and Commission Directive 2013/28/EU<sup>10</sup> of 17 May 2013 and Commission Directive 2016/774/EU<sup>11</sup> of 18 May 2016 and Commission Directive (EU) 2017/2096<sup>12</sup> of 15 November 2017 and Commission Delegated Directives (EU) 2020/362<sup>13</sup> and (EU) 2020/363<sup>14</sup> of 17 December 2019;”.

EXPLANATORY NOTE

*(This note is not part of the Instrument and does not purport to be a legal interpretation)*

These Regulations amend the European Union (End-of-Life Vehicles) Regulations 2014 in order to give effect to the provisions of the following Commission Delegated Directives:

- a) Commission Delegated Directive 2020/362/EU of 17 December 2019 amending Annex II to Directive 2000/53/EC of the European Parliament and of the Council on end-of-life vehicles as regards the exemption for hexavalent chromium as anti-corrosion agent of the carbon steel cooling system in absorption refrigerators in motor caravans;
- b) Commission Delegated Directive 2020/363/EU of 17 December 2019 amending Annex II to Directive 2000/53/EC of the European Parliament and of the Council on end-of-life vehicles as regards certain exemptions for lead and lead compounds in components.
