1. This Order may be cited as the Speech and Language Therapists Registration Board (Establishment Day) Order 2012.
2. The 1st day of November 2012 is appointed as the establishment day of the Speech and Language Therapists Registration Board.

EXPLANATORY NOTE

The effect of this Order is to establish, under the Health and Social Care Professionals Act 2005, a body known as the Speech and Language Therapists Registration Board, which will register Speech and Language Therapists, thus protecting the public by fostering high standards of professional conduct and professional education, training and competence among registrants of the speech and language therapy profession.
