I, SIMON COVENEY, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Directive 2012/14/EU of 8 May 2012<sup>1</sup>, Commission Directive 2012/15/EU of 8 May 2012<sup>2</sup>, Commission Directive 2012/16/EU of 10 May 2012<sup>3</sup>, Commission Directive 2012/20/EU of 6 July 2012<sup>4</sup>, Commission Directive 2012/22/EU of 22 August 2012<sup>5</sup>, Commission Directive 2012/38/EU of 23 November 2012<sup>6</sup>, Commission Directive 2012/40/EU of 26 November 2012<sup>7</sup>, Commission Directive 2012/41/EU of 26 November 2012<sup>8</sup>, Commission Directive 2012/42/EU of 26 November 2012<sup>9</sup> and Commission Directive 2012/43/EU of 26 November 2012<sup>10</sup> hereby make the following regulations:

1. These Regulations may be cited as the European Communities (Authorisation, Placing on the Market, Use and Control of Biocidal Products) (Amendment) Regulations 2013.

2. The European Communities (Authorisation, Placing on the Market, Use and Control of Biocidal Products) Regulations, 2001 (S.I. No. 625 of 2001) are amended in Regulation 2(1) by substituting for the definition of “the Directive of 1998” (inserted by the European Communities (Authorisation, Placing on the Market, Use and Control of Biocidal Products) (Amendment) Regulations 2012 (S.I. No.93 of 2012)) the following—
