EUROPEAN COMMUNITIES (TWO AND THREE WHEEL MOTOR
VEHICLE ENTRY INTO SERVICE) (AMENDMENT) REGULATIONS
2014

I, LEO VARADKAR, Minister for Transport, in exercise of the power conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Directive 2013/60/EU of 27 November 2013¹, amending Directive 2002/24/EC of the European Parliament and of the Council² in so far as it relates to the entry into service of two or three-wheel motor vehicles, hereby make the following regulations:

1. These Regulations may be cited as the European Communities (Two and Three Wheel Motor Vehicle Entry into Service) (Amendment) Regulations 2014.

2. Regulation 2(1) of the European Communities (Two and Three Wheel Motor Vehicle Entry into Service) Regulations 2005 (S.I. No. 412 of 2005) is amended by substituting for the definition of “Council Directive” the following definition:

“‘Council Directive’ means Directive 2002/24/EC of the European Parliament and of the Council of 18 March 2002², as amended by Commission Directive 2003/77/EC of 11 August 2003, Act concerning the conditions of accession of the Czech Republic, the Republic of Estonia, the Republic of Cyprus, the Republic of Latvia, the Republic of Lithuania, the Republic of Hungary, the Republic of Malta, the Republic of Poland, the Republic of Slovenia and the Slovak Republic and the adjustments to the Treaties on which the European Union is founded³, Commission Directive 2005/30/EC of 22 April 2005⁴, Council Directive 2006/96/EC of 20 November 2006, Commission Directive 2006/120/EC of 27 November 2006⁵, Regulation (EC) No. 1137/2008 of the European Parliament and of the Council of 22 October 2008⁶, Council Directive 2013/15/EU of 13 May 2013⁷ and Commission Directive 2013/60/EU of 27 November 2013⁸.”

EXPLANATORY NOTE

(This note is not part of the instrument and does not purport to be a legal interpretation.)

The European Communities (Two and Three Wheel Motor Vehicle Entry into Service) Regulations 2005 (S.I. No. 412 of 2005) gave effect to Directive 2002/24/EC (the Framework Directive) and to each of the separate Directives that individually regulate many components, systems and separate technical units, in so far as those Directives relate to the registration and entry into service of two or three wheel motor vehicles. The reference to Directive 2002/24/EC in the 2005 Regulations is now updated in order to take account of Commission Directive 2013/60/EU, in so far as that Directive relates to the entry into service of two or three-wheel motor vehicles.

These Regulations may be cited as the European Communities (Two and Three Wheel Motor Vehicle Entry into Service) (Amendment) Regulations 2014.
