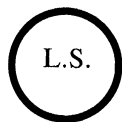
I, ALAN KELLY, Minister for the Environment, Community and Local Government, in exercise of the powers conferred on me by section 1(4) of the Residential Tenancies (Amendment) Act 2015 (No. 42 of 2015), hereby order as follows:

1. This Order may be cited as the Residential Tenancies (Amendment) Act 2015 (Commencement of Certain Provisions) Order 2015.

2. The 1st day of January 2016 is appointed as the day on which the following provisions of the Residential Tenancies (Amendment) Act 2015 (No. 42 of 2015) come into operation:

(a) section 2;

(b) paragraph (d) of section 63, insofar as it relates to the insertion of subsection (7) into section 139 of the Residential Tenancies Act 2004 (No. 27 of 2004).

EXPLANATORY NOTE
