- I, MARY COUGHLAN, Minister for Agriculture, Fisheries and Food, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Directive No. 2006/127/EC of 7 December 2006¹, hereby make the following regulations—
- 1. These Regulations may be cited as the European Communities (Minimum Conditions for Examining of Vegetable Species) (Amendment) Regulations 2007.
- 2. The European Communities (Minimum Conditions for Examining of Vegetable Species) Regulations 2004 (S.I. No. 121 of 2004) are amended in Regulation 2 by substituting for the definition of "Directive", the following—
 - "'Directive' means Commission Directive 2003/91/EC of 6 October 2003² and Commission Directive 2006/127/EC of 7 December 2006".
