CRIMINAL JUSTICE (TERRORIST OFFENCES) ACT 2005 (SECTION 42(2)) (USAMA BIN LADEN, THE AL-QAIDA NETWORK AND THE TALIBAN) (FINANCIAL SANCTIONS) REGULATIONS (No. 3) 2009

- I, BRIAN LENIHAN, Minister for Finance, in exercise of the powers conferred on me by section 42(2) of the Criminal Justice (Terrorist Offences) Act 2005 (No. 2 of 2005), for the purpose of giving full effect to certain acts that are adopted by the institutions of the European Communities, and being of the opinion that Council Regulation (EC) No. 881/2002 of 27 May 2002<sup>1</sup>, as amended, is for the purpose of, or will contribute to, combating terrorism through the adoption of specific restrictive measures, directed at persons, groups or entities, for the identification, detection, freezing or seizure of their assets of any kind, hereby make the following Regulations:
- 1. These Regulations may be cited as the Criminal Justice (Terrorist Offences) Act 2005 (Section 42(2)) (Usama bin Laden, the Al-Qaida network and the Taliban) (Financial Sanctions) Regulations (No. 3) 2009.
  - 2. (1) In these Regulations—

- (e) Commission Regulation (EC) No. 344/2009 of 24 April 2009<sup>5</sup>,
- (f) Commission Regulation (EC) No. 490/2009 of 10 June 2009<sup>6</sup>,
- (g) Commission Regulation (EC) No. 574/2009 of 30 June 2009<sup>7</sup>,

- (h) Commission Regulation (EC) No. 601/2009 of 9 July 20098,
- (i) Commission Regulation (EC) No. 678/2009 of 27 July 20099,
- (j) Commission Regulation (EC) No. 732/2009 of 10 August 2009<sup>10</sup>,
- (k) Commission Regulation (EC) No. 774/2009 of 25 August 2009<sup>11</sup>,
- (1) Commission Regulation (EC) No. 937/2009 of 7 October 2009<sup>12</sup>, and
- (m) Commission Regulation (EC) No. 954/2009 of 13 October 2009<sup>13</sup>.
- (2) A word or expression which is used in these Regulations and which is also used in the Council Regulation has, unless the context otherwise requires, the same meaning in these Regulations as it has in the Council Regulation.
  - 3. Every person shall comply with the Council Regulation.
- 4. A person shall not do anything to directly or indirectly circumvent the provisions of the Council Regulation or of these Regulations.

## **EXPLANATORY NOTE**

(This note is not part of the Statutory Instrument and does not purport to be a legal interpretation).

These Regulations provide for enforcement of financial sanctions against certain persons and entities associated with Usama bin Laden, the Al-Qaida network and the Taliban imposed by Council Regulation (EC) No. 881/2002 of 27 May 2002, as amended by Council Regulation (EC) No. 561/2003 of 27 March 2003, Annex II of Act of Accession 2004, Council Regulation (EC) No. 1791/2006 of 20 November 2006 and various Commission Regulations.

This update provides for enforcement of the additional amending Commission Regulations, which add to or remove entries from the asset-freeze list:

Commission Regulation (EC) No. 490/2009 of 10 June 2009
Commission Regulation (EC) No. 574/2009 of 30 June 2009
