1. This Order may be cited as the Voluntary Health Insurance (Amendment) Act 2008 (Appointment of date pursuant to subsection (5)(b) of section 2 of the Voluntary Health Insurance (Amendment) Act 1996) (No. 3) Order 2009.

2. The 31st day of March 2010 is appointed pursuant to subsection (5)(b) of section 2 (as amended by section 6 of the Voluntary Health Insurance (Amendment) Act 2008 (No. 6 of 2008)) of the Voluntary Health Insurance (Amendment) Act 1996 (No. 4 of 1996).
