EUROPEAN COMMUNITIES (ROAD TRANSPORT ACTIVITIES CHECKS) (AMENDMENT) REGULATIONS 2010

I, NOEL DEMPSEY, Minister for Transport, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) and for the purposes of giving effect to Commission Directive No. 2009/4/EC of 23 January 2009¹ and Commission Directive 2009/5/EC of 30 January 2009², hereby make the following regulations:

1. These Regulations may be cited as the European Communities (Road Transport Activities Checks) (Amendment) Regulations 2010.

2. Regulation 2(1) of the European Communities (Road Transport Activities Checks) Regulations 2007 (S.I. No. 545 of 2007) is amended by substituting for the definition of "Directive" the following:

" "Directive" means Directive No. 2006/22/EC of the European Parliament and of the Council of 15 March 2006³ as amended by Commission Directive 2009/4/EC of 23 January 2009¹ and Commission Directive 2009/5/EC of 30 January 2009²;".
