
EUROPEAN COMMUNITIES (INTRA-COMMUNITY TRANSFERS OF DEFENCE RELATED PRODUCTS) (AMENDMENT) REGULATIONS 2012

- I, RICHARD BRUTON, Minister for Jobs, Enterprise and Innovation, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) and for the purpose of giving effect to Commission Directive 2012/10/EU of 22 March 2012¹ amending Directive 2009/43/EC of the European Parliament and of the Council as regards the list of defence-related products, hereby make the following regulations:
- 1. These Regulations may be cited as the European Communities (Intra-Community Transfers of Defence Related Products) (Amendment) Regulations 2012.
- 2. Regulation 2 of the European Communities (Intra-Community Transfers of Defence Related Products) Regulations 2011 (S.I. No. 346 of 2011), as amended by the European Communities (Intra-Community Transfers of Defence Related Products) (Amendment) Regulations 2011 (S.I. No. 535 of 2011), is amended, in paragraph (1), by substituting for the definition of "Directive" the following definition:
 - "'Directive' means Directive 2009/43/EC of the European Parliament and of the Council of 6 May 2009² simplifying terms and conditions of transfers of defence-related products within the Community (as amended by Commission Directive 2010/80/EU of 22 November 2010³ amending Directive 2009/43/EC of the European Parliament and of the Council as regards the list of defence-related products and Commission Directive 2012/10/EU of 22 March 2012¹ amending Directive 2009/43/EC of the European Parliament and of the Council as regards the list of defence-related products);".

EXPLANATORY NOTE
