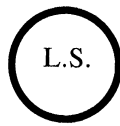

ENERGY (MISCELLANEOUS PROVISIONS) ACT 2012 (SECTIONS 17,  
18 AND 19) (COMMENCEMENT) ORDER 2013

I, PAT RABBITTE, Minister for Communications, Energy and Natural Resources, in exercise of the powers conferred on me by section 1(2) of the Energy (Miscellaneous Provisions) Act 2012 (No. 3 of 2012), hereby order as follows:

1. This Order may be cited as the Energy (Miscellaneous Provisions) Act 2012 (Sections 17, 18 and 19) (Commencement) Order 2013.

2. The day appointed as the day on which sections 17 (other than subsection (2)(f)), 18 and 19 of the Energy (Miscellaneous Provisions) Act 2012 (No. 3 of 2012) come into operation is 24 January 2013.
