EUROPEAN COMMUNITIES (RESTRICTIVE MEASURES AGAINST CERTAIN PERSONS AND ENTITIES ASSOCIATED WITH USAMA BIN LADEN, THE AL-QAIDA NETWORK AND THE TALIBAN) (AMENDMENT) REGULATIONS 2013

I, RICHARD BRUTON, Minister for Jobs, Enterprise and Innovation, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) and for the purpose of giving further effect to Council Regulation (EC) No. 881/2002 of 27 May 2002<sup>1</sup> as last amended by Commission Regulation (EU) No. 1187/2012 of 11 December 2012<sup>2</sup>, hereby make the following regulations:

1. These Regulations may be cited as the European Communities (Restrictive Measures against Certain Persons and Entities Associated with Usama bin Laden, the Al-Qaida Network and the Taliban) (Amendment) Regulations 2013.

2. Regulation 2 (amended by the European Communities (Restrictive Measures against Certain Persons and Entities Associated with Usama bin Laden, the Al-Qaida Network and the Taliban) (Amendment) (No. 2) Regulations 2011 (S.I. No. 415 of 2011)) of the European Communities (Restrictive Measures against Certain Persons and Entities Associated with Usama bin Laden, the Al-Qaida Network and the Taliban) Regulations 2006 (S.I. No. 186 of 2006) is amended—

(a) in paragraph (cl), by the deletion of “and”,

(b) in paragraph (cli) by the substitution of “30 June 2011<sup>154</sup>,” for “30 June 2011<sup>154</sup>.”, and

(c) by the insertion of the following paragraphs after paragraph (cli):

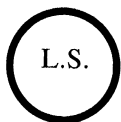

EXPLANATORY NOTE

*(This note is not part of the Instrument and does not purport to be a legal interpretation.)*

The effect of this Regulation is to amend the Statutory Instrument that provided for penalties for infringements of Council Regulation (EC) No. 881 of 2002, as last amended by Commission Regulation (EU) No. 1187/2012, which introduced measures against certain persons and entities associated with Usama bin Laden, the Al-Qaida Network and the Taliban.
