I, MICHAEL NOONAN, Minister for Finance, in exercise of the powers conferred on me by subsection (7) (inserted by section 7(2)(b) of the Finance Act 2013 (No. 8 of 2013)) of section 472A of the Taxes Consolidation Act 1997 (No. 39 of 1997), hereby order as follows:

1. This Order may be cited as the Taxes Consolidation Act 1997 (Cessation of section 472A in respect of certain claims) Order 2013.

2. The 1st day of July 2013 is appointed as the day on which section 472A of the Taxes Consolidation Act 1997 (No. 39 of 1997) shall cease to have effect for the purposes of subsection (7) (inserted by section 7(2)(b) of the Finance Act 2013 (No. 8 of 2013)) of that section.
