## EUROPEAN COMMUNITIES (AGRICULTURAL OR FORESTRY TRACTORS TYPE APPROVAL) (AMENDMENT) REGULATIONS 2013

I, SIMON COVENEY, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) and for the purpose of giving effect to Commission Directive 2012/24/EU of 8 October 2012<sup>1</sup>, Commission Directive 2013/8/EU of 26 February 2013<sup>2</sup> and Council Directive 2013/15/EU of 13 May 2013<sup>3</sup>, hereby make the following regulations:

1. These Regulations may be cited as the European Communities (Agricultural or Forestry Tractors Type Approval) (Amendment) Regulations 2013.

2. Regulation 2(1) of the European Communities (Agricultural or Forestry Tractors Type Approval) Regulations 2011 (S.I. No. 531 of 2011) is amended by substituting for the definition of "separate directives" the following—

" 'separate directives' means the directives listed in Annex II, Chapter B to the Tractor Directive and includes Directive 2009/144/EC of the European Parliament and of the Council of 30 November 2009<sup>4</sup> (as amended by Commission Directive 2010/52/EU of 11 August 2010<sup>5</sup>, Commission Directive 2010/62/EU of 8 September 2010<sup>6</sup> and Commission Directive 2013/8/EU of 26 February 2013) and Council Directive 86/297/EEC of 26 May 1986<sup>7</sup> (as amended by Directive 97/54/EC of the European Parliament and of the Council of 23 September 1997<sup>8</sup>, Commission Directive 2010/62/EU of 8 September 2010 and Commission Directive 2012/24/EU of 8 October 2012);".

3. Where a Directive mentioned in the definition of "separate directives" or "Tractor Directive" in Regulation 2(1) of the European Communities (Agricultural or Forestry Tractors Type Approval) Regulations 2011 is also mentioned in Article 1 of Council Directive 2013/15/EU of 13 May 2013, the definition of "separate directives" and "Tractor Directive" shall apply as amended in the Annex to Council Directive 2013/15/EU of 13 May 2013.

4. The European Communities (Agricultural or Forestry Tractors Type Approval) (No. 2) Regulations 2000 (S.I. No. 286 of 2000) are revoked.
