ENERGY AND NATURAL RESOURCES (DELEGATION OF MINISTERIAL FUNCTIONS) ORDER 2014

The Government, on the request of the Minister for Communications, Energy and Natural Resources and in exercise of the powers conferred on them by subsection (1) of section 2 of the Ministers and Secretaries (Amendment) (No. 2) Act 1977 (No. 28 of 1977), hereby order as follows:

- 1. This Order may be cited as the Energy and Natural Resources (Delegation of Ministerial Functions) Order 2014.
- 2. The powers (other than the power to prosecute an offence) and duties of the Minister for Communications, Energy and Natural Resources conferred on him—
 - (a) by or under the enactments specified in Part 1 of the Schedule,
 - (b) by or under the provisions of the enactments specified in Part 2 of the Schedule, and
 - (c) under the Regulations specified in Part 3 of the Schedule,

are delegated to Joe McHugh, Minister of State at the Department of Communications, Energy and Natural Resources.
