EUROPEAN UNION (BEEF PRODUCER ORGANISATIONS)
(AMENDMENT) REGULATIONS 2016

I, MICHAEL CREED, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) for the purpose of giving effect to Chapter III of Title II of Part II of Regulation (EU) No 1308/2013 of the European Parliament and of the Council of 17 December 2013¹ in so far as it relates to beef and veal, hereby make the following regulations:

1. These Regulations may be cited as the European Union (Beef Producer Organisations) (Amendment) Regulations 2016.

2. The European Union (Beef Producer Organisations) Regulations 2016 (S.I. No. 49 of 2016) are amended—

(a) in Regulation 2 by substituting for subparagraph (a) of the definition of “authorised officer” the following—

“(a) a person appointed under Regulation 9, or”,

(b) in Regulation 4 by substituting for paragraph (2) the following—

“(2) The Minister may from time to time publish the register established under Regulation 3 or such extract as the Minister considers appropriate.”, and

(c) in Regulation 15 by substituting for paragraph (1) the following—

“(1) A person who fails to comply with Regulation 4(5), Regulation 5 or Regulation 14 commits an offence and is liable on summary conviction to a class A fine.

(1A) The Minister may prosecute an offence in a summary manner.”.
