EUROPEAN UNION (RENEWABLE ENERGY) (AMENDMENT) REGULATIONS 2016

EUROPEAN UNION (RENEWABLE ENERGY) (AMENDMENT) REGULATIONS 2016

I, DENIS NAUGHTEN, Minister for Communications, Climate Action and Environment, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), and for the purposes of giving effect to Directive (EU) 2015/1513 of the European Parliament and of the Council of 9 September 2015¹, hereby make the following regulations:

1. (1) These Regulations may be cited as the European Union (Renewable Energy) (Amendment) Regulations 2016.

(2) These Regulations come into operation on 1 January 2017.

2. The European Union (Renewable Energy) Regulations 2014 (S.I. No. 483 of 2014) are amended—

(a) by substituting for the definition of "Directive" the following:

" 'Directive' means Directive 2009/28/EC of the European Parliament and of the Council of 23 April 2009², as amended by Article 2(5) of Directive (EU) 2015/1513 of the European Parliament and of the Council of 9 September 2015¹;",

(b) by substituting for paragraph 1 of Schedule 3 the following:

"1. The greenhouse gas emission saving from the use of biofuels and bioliquids shall be:

- (*a*) in the case of installations starting operation after 5 October 2015, at least 60 per cent;
- (b) in the case of installations that were in operation on or before 5 October 2015, at least 35 per cent until 31 December 2017 and at least 50 per cent from 1 January 2018.", and

(c) in Regulation 17(2), by substituting "paragraph (1)" for "paragraph (1)(a)".
