### DISTRICT COURT (ORDER 36) RULES 2020

- 1. (1) These Rules, which shall come into operation on the 10<sup>th</sup> day of November 2020, may be cited as the District Court (Order 36) Rules 2020.
- (2) These Rules shall be construed together with the District Court Rules 1997 (S.I. No. 93 of 1997) and all other District Court Rules.
- (3) The District Court Rules as amended by these Rules may be cited as the District Court Rules 1997 to 2020.
  - 2. The District Court Rules 1997 (S.I. No. 93 of 1997) are amended:
    - (i) by the substitution for rule 1 of Order 36 of the following rule:
      - "1. Where the Court makes an order in any case of summary jurisdiction (including an order to "strike out" for want of jurisdiction) it may make an order in accordance with law ordering any party to the proceedings to pay to the other party such costs and witnesses' expenses as it shall think fit to award."
