## SEA-FISHERIES (REVOCATION) REGULATIONS 2021

I, CHARLIE MCCONALOGUE, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by sections 3 and 14 of the Sea-Fisheries and Maritime Jurisdiction Act 2006 (No. 8 of 2006) and the Sea-Fisheries, Foreshore and Dumping at Sea (Transfer of Departmental Administration and Ministerial Functions) Order 2007 (S.I. No. 707 of 2007) (as adapted by the Agriculture, Fisheries and Food (Alteration of Name of Department and Title of Minister) Order 2011 (S.I. No. 455 of 2011)), for the purpose of giving full effect to Commission Implementing Regulation (EU) No 404/2011 of 8 April 2011<sup>1</sup>, Regulation (EU) 2019/1241 of the European Parliament and of the Council of 20 June 2019<sup>2</sup> and Commission Regulation (EC) No 129/2003 of 24 January 2003<sup>3</sup>, hereby make the following regulations:

1. These Regulations may be cited as the Sea-Fisheries (Revocation) Regulations 2021.

- 2. The following statutory instruments are revoked:
  - (*a*) the Passive Fishing Gear and Beam Trawls Marking and Identification (No.2) Regulations 2006 (S.I. No. 341 of 2006);
  - (b) the Sea Fisheries (Tuna and Certain Other Species Fishing) Regulations 2005 (S.I. No. 353 of 2005);
  - (c) the Sea Fisheries (Tuna and Certain Other Species Fishing) Order, 2002 (S.I. No. 322 of 2002);
  - (*d*) the Sea Fisheries (Regulation of Nets) Order, 1993, (S.I. No. 264 of 1993).
