EUROPEAN COMMUNITIES (MINIMUM CONDITIONS FOR EXAMINING OF VEGETABLE SPECIES) (AMENDMENT) (NO. 2) REGULATIONS 2021

- I, CHARLIE MCCONALOGUE, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Implementing Directive (EU) 2021/746 of 6 May 2021 ¹, hereby make the following regulations:
- 1. These Regulations may be cited as the European Communities (Minimum Conditions for Examining of Vegetable Species) (Amendment) (No. 2) Regulations 2021.
- 2. The European Communities (Minimum Conditions for Examining of Vegetable Species) Regulations 2004 (S.I. No. 121 of 2004) are amended by substituting in Regulation 2 for the definition of "Directive" (as amended by European Communities (Minimum Conditions for examining of Vegetable Species) (Amendment) Regulations 2020 (S.I. No. 49 of 2020) the following-

"Directive' means Commission Directive No. 2003/91/EC of 6 October 2003² as amended by Commission Implementing Directive (EU) 2021/746 of 6 May 2021;".

3. The European Communities (Minimum Conditions for Examining of Vegetable Species) (Amendment) Regulations 2020 (S.I. No. 49 of 2020) are revoked.
