INTOXICATING LIQUOR ACT 2003 (SECTION 21) (CROKE PARK,  
DUBLIN) REGULATIONS 2011

I, JIMMY DEENIHAN, Minister for Tourism, Culture and Sport in exercise of the powers conferred on me by section 21 of the Intoxicating Liquor Act 2003 (No. 31 of 2003) (as adapted by the Arts, Sport and Tourism (Alteration of Name of Department and Title of Minister) Order 2010 (S.I. No. 178 of 2010)) make the following regulations:

1. These Regulations may be cited as the Intoxicating Liquor Act 2003 (Section 21) (Croke Park, Dublin) Regulations 2011.
2. In these Regulations “Act of 2003” means the Intoxicating Liquor Act 2003 (No. 31 of 2003).
3. The stadium, known as Croke Park, situated at Jones's Road in the city of Dublin is designated as a national sporting arena.
4. The areas indicated by the colour red on the maps of the designated national sporting arena referred to in Regulation 3 set out in Schedule 1 are prescribed for the purposes of paragraph (a) of section 21(4) of the Act of 2003.
5. The areas indicated by the colour blue on the maps of the designated national sporting arena referred to in Regulation 3 set out in Schedule 2 are prescribed for the purposes of paragraph (b) of section 21(4) of the Act of 2003.
6. The Intoxicating Liquor Act 2003 (Section 21) Regulations 2004 (S.I. No. 271 of 2004) are revoked.
