2006 (VESTING) ORDER 2012

I, SIMON COVENEY, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by sections 7(8) and 30(1) of the National Sports Campus Development Authority Act 2006 (No. 19 of 2006) (as adapted by the Agriculture, Fisheries and Food (Alteration of Name of Department and Title of Minister) Order 2011 (S.I. No. 455 of 2011)), hereby make the following order:

1. This Order may be cited as the National Sports Campus Development Authority Act 2006 (Vesting) Order 2012.


2. The land described in the Schedule (and shown outlined in red on the maps annexed to this Order) shall, on the 15th day of August 2012, vest in the National Sports Campus Development Authority for all the estate and interest of the Minister for Agriculture, Food and the Marine therein but subject to all trusts and equities affecting that land subsisting and capable of being performed.


