PUBLIC SERVICE PENSIONS (SINGLE SCHEME AND OTHER PROVISIONS) ACT 2012 (RELEVANT AUTHORITIES) REGULATIONS 2012

I, BRENDAN HOWLIN, Minister for Public Expenditure and Reform, in exercise of the powers conferred on me by section 8(1)(b) of the Public Service Pensions (Single Scheme and Other Provisions) Act 2012 (No. 37 of 2012), make the following regulations:

1. (1) These Regulations may be cited as the Public Service Pensions (Single Scheme and Other Provisions) Act 2012 (Relevant Authorities) Regulations 2012.

(2) These Regulations shall come into operation on 1 January 2013.

2. The Ministers of the Government, public service bodies and bodies corporate specified in the Schedule are each prescribed as a relevant authority for the purposes of the Public Service Pensions (Single Scheme and Other Provisions) Act 2012 (No. 37 of 2012).

These Regulations prescribe Ministers of the Government, public service bodies and bodies corporate as “relevant authorities” for the purposes of the Single Public Service Pension Scheme as provided for in Part 2 of the Public Service Pensions (Single Scheme and Other Provisions) Act 2012. Relevant authorities represent the paying authority or employer equivalent in the Single Scheme’s functioning and operation; their responsibilities include ensuring the correct collection and remittance of member contributions, the calculation and recording of accrued benefits, and communications with members.
