EUROPEAN COMMUNITIES (AEROSOL DISPENSERS)
(AMENDMENT) REGULATIONS 2014

I, RICHARD BRUTON, Minister for Jobs, Enterprise and Innovation, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) and for the purposes of giving further effect to Council Directive No. 75/324/EEC of 20 May 1975¹ and effect to Commission Directive No. 2013/10/EU of 19 March 2013², hereby make the following regulations:

1. (1) These Regulations may be cited as the European Communities (Aerosol Dispensers) (Amendment) Regulations 2014.

(2) These Regulations come into operation from—

(a) 19 June 2014 as regards aerosol dispensers containing a substance,

(b) 1 June 2015 as regards aerosol dispensers containing mixtures other than such dispensers referred to in paragraph (c), and

(c) 1 June 2017 as regards aerosol dispensers containing mixtures which are placed on the market before 1 June 2015.

2. The European Communities (Aerosol Dispensers) Regulations 1977 (S.I. No. 144 of 1977) are amended in Regulation 2(1) by substituting for the definition of “the Council Directive” (inserted by Regulation 2(a)(ii) of the European Communities (Aerosol Dispensers) (Amendment) Regulations 2009 (S.I. No. 446 of 2009)) the following:

“‘Council Directive’ means Council Directive 75/324/EEC of 20 May 1975¹, as amended by Commission Directive 94/1/EC of 6 January 1994³, Directive 2007/45/EC of the European Parliament and of the Council of 5 September 2007⁴, Commission Directive 2008/47/EC of 8 April 2008⁵ and Commission Directive 2013/10/EU of 19 March 2013².”
