SEA-FISHERIES (COMMUNITY CONTROL SYSTEM) (AMENDMENT)
(NO. 2) REGULATIONS 2022

I, CHARLIE MCCONALOGUE, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by sections 3 and 14 of the Sea-Fisheries and Maritime Jurisdiction Act 2006 (No. 8 of 2006) for the purpose of giving full effect to Council Regulation (EC) No 1224/2009 of 20 November 2009¹ (as amended by Regulation (EU) No 1379/2013 of the European Parliament and of the Council of 11 December 2013², Council Regulation (EU) No 1385/2013 of 17 December 2013³, Regulation (EU) No 508/2014 of the European Parliament and of the Council of 15 May 2014⁴ and Regulation (EU) No 2015/812 of the European Parliament and of the Council of 20 May 2015⁵) and Commission Implementing Regulation (EU) No 404/2011 of 8 April 2011⁶ (other than Title VII) (as amended by Commission Implementing Regulation (EU) 2015/1962 of 28 October 2015⁷), hereby make the following regulations:

1. These Regulations may be cited as the Sea-Fisheries (Community Control System) (Amendment) (No. 2) Regulations 2022.

2. The Sea-Fisheries (Community Control System) Regulations 2016 (S.I. No. 54 of 2016) is amended by substituting the following for the Schedule (as inserted by the Sea-Fisheries (Community Control System) (Amendment) Regulations 2019 (S.I. No. 365 of 2019)):

These Regulations provide for the removal of Rathmullan and the Port of Cork as designated ports for landings of pelagic species greater than 10 tonnes.
