WILDLIFE ACT 1976 (TEMPORARY SUSPENSION OF OPEN SEASON)  
(NO. 2) ORDER 2010

The Minister for the Environment, Heritage and Local Government, in exercise of the powers conferred on him by sections 8 and 27 of the Wildlife Act, 1976 (No. 39 of 1976) as amended by section 7 of the Wildlife (Amendment) Act, 2000 (No. 38 of 2000) (as adapted by the Environment and Local Government (Alteration of Name of Department and Title of Minister Order 2003 (S.I. No. 233 of 2003)) and being satisfied that because of the severity of weather conditions occurring in the State it is desirable, in the interest of conserving wild birds, to make an order under section 27 of the Wildlife Act, 1976 (No. 39 of 1976), hereby orders as follows:

1. This Order may be cited as the Wildlife Act 1976 (Temporary Suspension of Open Season) (No. 2) Order 2010.

2. The Wildlife (Wild Birds) (Open Seasons) Orders, 1979 to 2003, and this Order may be cited together as the Wildlife (Wild Birds) (Open Seasons) Orders, 1979 to 2010.

3. The hunting of any protected wild bird which is of a species specified in the Schedule to this Order being species each of which is specified in the Wildlife (Wild Birds) (Open Seasons) Order, 1979 (S.I. No. 192 of 1979) as amended by the Wildlife (Wild Birds) (Open Seasons) (Amendment) Order, 1980 (S. I. No. 229 of 1980); Wildlife (Wild Birds) (Open Seasons) (Amendment) Order, 1982 (S.I. No. 266 of 1982); Wildlife (Wild Birds) (Open Seasons) (Amendment) Order, 1985 (S.I. No. 346 of 1985); Wildlife (Wild Birds) (Open Seasons) (Amendment) (No.2) Order, 1985 (S.I.
