## EUROPEAN COMMUNITIES (AUTHORIZATION, PLACING ON THE MARKET, USE AND CONTROL OF PLANT PROTECTION PRODUCTS) (AMENDMENT) (No. 2) REGULATIONS 2011

1. These Regulations may be cited as the European Communities (Authorization, Placing on the Market, Use and Control of Plant Protection Products) (Amendment) (No. 2) Regulations 2011.

2. The European Communities (Authorization, Placing on the Market, Use and Control of Plant Protection Products) Regulations 2003 (S.I. No. 83 of 2003) are amended in Regulation 2(1) by substituting for the definition of “Directive of 1991” (inserted by the European Communities (Authorization, Placing on the Market, Use and Control of Plant Protection Products) (Amendment) Regulations 2011 (S.I. No. 104 of 2011)) the following—

## EXPLANATORY NOTE

*(This note is not part of the Instrument and does not purport to be a legal interpretation)*

These Regulations transpose the amendments to Annex I of Council Directive 91/414/EEC

— as regards a restriction on the use of the active substance pirimiphos-methyl.

— as regards the renewal of the inclusion of carbendazim as active substance

and

— by including the following active substances into that Annex:

zinc phosphide, fenbuconazole, quinmerac, pyridaben, metosulam, 6-Benzyladenine, myclobutanil, cycloxydim, hymexazol, dodine, tau-fluvalinate, fenoxycarb, clethodim, triflumuron, bupirimate, diethofencarb, oryzalin, indolylbutyric acid, etridiazole, fenbutatin oxide, isoxaben, 1-decanol, flurochloridone, fenazaquin, sintofen, dithianon, flutriafol, lime sulphur, azadirachtin, diclofop, hexythiazox, aluminium sulphate, bromadiolone, pencycuron, carbetamide, carboxin, dazomet, metaldehyde, paclobutrazol, cyproconazole, fluometuron, tebufenozide, captan, folpet, formetanate and methiocarb.

These substances are pesticides.
