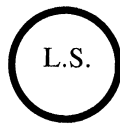

EUROPEAN COMMUNITIES (CONTROL ON MUSSEL FISHING)  
REGULATIONS 2008 (AMENDMENT) REGULATIONS 2011

I, SIMON COVENEY, Minister for Agriculture, Fisheries and Food, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving further effect to Council Directive 92/43/EEC of 21 May 1992<sup>1</sup> (as amended by Council Directive 97/62/EC of 27 October 1997<sup>2</sup>, Regulation (EC) No. 1882/2003 of the European Parliament and of the Council of 29 September 2003<sup>3</sup> and Council Directive 2006/105/EC of 20 November 2006<sup>4</sup>) and Directive 2009/147/EC of the European Parliament and of the Council of 30 November 2009<sup>5</sup>, so far as those Directives relate to the impact of sea-fisheries on the marine environment, hereby make the following regulations:

1. These Regulations may be cited as the European Communities (Control on Mussel Fishing) Regulations 2008 (Amendment) Regulations 2011.
2. The European Communities (Control on Mussel Fishing) Regulations 2008 (S.I. No. 347 of 2008) are amended by deleting, in the Schedule, paragraph (u) (inserted by the European Communities (Control on Mussel Fishing) (Amendment) (No. 2) Regulations 2010 (S.I. No. 592 of 2010)).
3. The European Communities (Control on Mussel Fishing) Regulations (Amendment) (No. 2) Regulations 2010 (S.I. No. 592 of 2010) are revoked.

EXPLANATORY NOTE

These Regulations are to provide for the removal of the prohibition on fishing for mussel seed within a defined area of Dingle Bay in connection with the Birds and Habitats Directives.
