LOBSTER (CONSERVATION OF STOCKS) (AMENDMENT)
REGULATIONS 2017

I, MICHAEL CREED, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by sections 3 and 15 of the Sea-Fisheries and Maritime Jurisdiction Act 2006 (No. 8 of 2006) and the Sea-Fisheries, Fore-shore and Dumping at Sea (Transfer of Departmental Administration and Ministerial Functions) Order 2007 (S.I. No. 707 of 2007) (as adapted by the Agriculture, Fisheries and Food (Alteration of Name of Department and Title of Minister) Order 2011 (S.I. No. 455 of 2011)), hereby make the following regulations:

1. These Regulations may be cited as the Lobster (Conservation of Stocks) (Amendment) Regulations 2017.

2. The Lobster (Conservation of Stocks) Regulations 2014 (S.I. No. 591 of 2014) are amended:

(a) In Regulation 4(3) by substituting “1 January 2019” for “1 January 2018” (as amended by Lobster (Conservation of Stocks) (Amendment) Regulations 2016 (S.I. No. 679 of 2016));

(b) In Regulation 9(2) by substituting “1 January 2019” for “1 January 2018” (as amended by Lobster (Conservation of Stocks) (Amendment) Regulations 2016).

3. The Lobster (Conservation of Stocks) (Amendment) Regulations 2016 (S.I. No. 679 of 2016) are revoked.
