ENTERPRISE, TOURISM AND EMPLOYMENT (DELEGATION OF MINISTERIAL FUNCTIONS) (NO. 2) ORDER 2025

The Government, on the request of the Minister for Enterprise, Tourism and Employment and in exercise of the powers conferred on them by section 2(1) of the Ministers and Secretaries (Amendment) (No. 2) Act 1977 (No. 28 of 1977), hereby order as follows:

- 1. This Order may be cited as the Enterprise, Tourism and Employment (Delegation of Ministerial Functions) (No. 2) Order 2025.
- 2. The powers (other than the power to prosecute an offence) and duties of the Minister for Enterprise, Tourism and Employment conferred on him
 - (a) by or under the enactments specified in Part 1 of the Schedule,
 - (b) by or under the provisions of the enactment specified in Part 2 of the Schedule, and
- (c) under the Regulations specified in Part 3 of the Schedule, are delegated to Niamh Smyth, Minister of State at the Department of Enterprise, Tourism and Employment.
