EUROPEAN COMMUNITIES (VEHICLE TESTING) (AMENDMENT) REGULATIONS 2007

- I, NOEL DEMPSEY, Minister for Transport, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) and for the purpose of giving further effect to Council Directive 96/96/EC of 20 December 1996¹, hereby make the following regulations:
- 1. (1) These Regulations may be cited as the European Communities (Vehicle Testing) (Amendment) Regulations 2007.
 - (2) These Regulations come into operation on 29 October 2007.
- 2. The European Communities (Vehicle Testing) Regulations 2004 (S.I. No. 771 of 2004) are amended by substituting for Schedule 1 the following:
