EUROPEAN COMMUNITIES (FEEDINGSTUFFS INTENDED FOR PARTICULAR NUTRITIONAL PURPOSES) (AMENDMENT) REGULATIONS, 2008

I, BRENDAN SMITH, Minister for Agriculture, Fisheries and Food, in exercise of the powers conferred on me by section 3 of the European Communities Act, 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Directive 2008/4/EC of 9 January 2008¹ hereby make the following Regulations:

1. These Regulations may be cited as the European Communities (Feedingstuffs Intended for Particular Nutritional Purposes) (Amendment) Regulations, 2008

2. The European Communities (Feedingstuffs Intended for Particular Nutritional Purposes) Regulations, 1996 (S.I. No. 59 of 1996) are amended—

(a) in Regulation 2(1) by substituting for the definition of "the Directive" the following—

" the Directive' means Council Directive 93/74/EEC of 13 September 1993², as amended by Commission Directive 94/39/EC of 25 July 1994³, Commission Directive 95/9/EC of 7 April 1995⁴, Commission Directive 95/10/EC of 7 April 1995⁵, Council Directive 96/25/EC of 29 April 1996⁶, Council Directive 99/78/EC of 27 July 1999⁷, Commission Directive 2002/1/EC of 7 January 2002⁸ and Commission Directive 2008/4/EC of 9 January 2008;"


(b) in the Part B of the Schedule to the Regulations, the line of the particular nutritional purpose 'reduction of the risk of milk fever' is replaced by the following—
