# BOROUGH OF DROGHEDA LOCAL ELECTORAL AREAS ORDER 2008

The Minister for the Environment, Heritage and Local Government, in exercise of the powers conferred on him by sections 3 and 24 of the Local Government Act 1994 (No. 8 of 1994), hereby orders as follows:

1. This order may be cited as the Borough of Drogheda Local Electoral Areas Order 2008.

2. In this Order "the Borough of Drogheda" means the Borough of Drogheda as altered for the purposes of local elections by the Local Government (Boundaries) (Town Elections) Regulations 1994 (S.I. No. 114 of 1994) and references to the borough boundary shall be construed accordingly.

3. (1) The Borough of Drogheda shall be divided into the local electoral areas which are named in the first column of the Schedule to this Order.

(2) Each such local electoral area shall consist of the area described in the second column of the Schedule to this Order opposite the name of such local electoral area.

(3) The number of members of Drogheda Borough Council to be elected for each such local electoral area shall be the number set out in the third column of the Schedule to this Order opposite the name of that local electoral area.

4. The Borough of Drogheda Local Electoral Areas Order 1998 (S.I. No. 370 of 1998) is hereby revoked.
