COUNTY OF LONGFORD LOCAL ELECTORAL AREAS ORDER 2008

The Minister for the Environment, Heritage and Local Government, in exercise of the powers conferred on him by sections 3 and 24 of the Local Government Act 1994 (No. 8 of 1994), hereby orders as follows:

- 1. This order may be cited as the County of Longford Local Electoral Areas Order 2008.
- 2. (1) The County of Longford shall be divided into the local electoral areas which are named in the first column of the Schedule to this Order.
- (2) Each such local electoral area shall consist of the area described in the second column of the Schedule to this Order opposite the name of such local electoral area.
- (3) The number of members of Longford County Council to be elected for each such local electoral area shall be the number set out in the third column of the Schedule to this Order opposite the name of that local electoral area.
- 3. Every reference in the Schedule to this Order to an electoral division or town shall be construed as referring to such electoral division or town as existing at the date of this Order.
- 4. The County of Longford Local Electoral Areas Order 1998 (S.I. No. 291 of 1998) is hereby revoked.
