- I, BRENDAN SMITH, Minister for Agriculture, Fisheries and Food, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), and for the purpose of giving effect to Commission Directive 2009/84/EC of 28 July 2009¹, Commission Directive 2009/85/EC of 29 July 2009², Commission Directive 2009/86/EC of 29 July 2009³, Commission Directive 2009/87/EC of 29 July 2009⁴, Commission Directive 2009/88/EC of 30 July 2009⁵, Commission Directive 2009/89/EC of 30 July 2009⁶, Commission Directive 2009/91/EC of 31 July 20097, Commission Directive 2009/92/EC of 31 July 20098, Commission Directive 2009/93/EC of 31 July 20099, Commission Directive 2009/94/EC of 31 July 2009¹⁰, Commission Directive 2009/95/EC of 31 July 2009¹¹, Commission Directive 2009/96/EC of 31 July 2009¹², Commission Directive 2009/98/EC of 4 August 2009¹³, Commission Directive 2009/99/EC of 4 August 2009¹⁴, Directive 2009/107/EC of the European Parliament and of the Council of 16 September 2009¹⁵, Commission Directive 2009/150/EC of 27 November 2009¹⁶ and Commission Directive 2009/151/EC of 27 November 2009¹⁷, hereby make the following Regulations:
- 1. These Regulations may be cited as the European Communities (Authorization, Placing on the Market, Use and Control of Biocidal Products) (Amendment) Regulations 2010.
- 2. The European Communities (Authorization, Placing on the Market, Use and Control of Biocidal Products) Regulations 2001 (S. I. No. 625 of 2001) are amended in Regulation 2(1), by substituting for the definition of "the Directive of 1998" (inserted by the European Communities (Authorization, Placing on
