1. This Order may be cited as the Health and Social Care Professionals Act 2005 (Transfer Day) Order 2011.

2. The 31st day of March 2011 is appointed as the transfer day for the purposes of Part 8 of the Health and Social Care Professionals Act 2005 (No. 27 of 2005).
