## EUROPEAN COMMUNITIES (OFFICIAL CONTROLS ON THE IMPORT OF FOOD OF NON-ANIMAL ORIGIN) (AMENDMENT) (NO. 2) REGULATIONS 2011

I, JAMES REILLY, Minister for Health, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) and for the purpose of giving effect to Commission Regulation (EU) No. 433/2011 of 4 May 2011<sup>1</sup>, hereby make the following regulations:

1. (1) These Regulations may be cited as the European Communities (Official Controls on the Import of Food of Non-Animal Origin) (Amendment) (No. 2) Regulations 2011.

(2) These Regulations come into operation on 1 July 2011.

2. In these Regulations, "Principal Regulations" means the European Communities (Official Controls on the Import of Food of Non-Animal Origin) Regulations 2010 (S.I. No. 391 of 2010).

3. Regulation 2(1) of the Principal Regulations is amended by substituting for the definition of "EC Regulation 669/2009" the following—

"'EC Regulation 669/2009' means Commission Regulation (EC) No. 669/2009 of 24 July 2009<sup>5</sup> implementing Regulation (EC) No. 882/2004 of the European Parliament and of the Council as regards the increased level of official controls on imports of certain feed and food of non-animal origin and amending Decision 2006/504/EC, as amended by Commission Implementing Regulation (EU) No. 433/2011 of 4 May 2011<sup>6</sup>;",

and by substituting for footnote 6 thereto the following:

"6OJ No. L. 115, 05.05.2011, p.5.".

4. The European Communities (Official Controls on the Import of Food of Non-Animal Origin) (Amendment) Regulations 2011 (S.I. No. 131 of 2011) are revoked.

## EXPLANATORY NOTE

(This note is not part of the Instrument and does not purport to be a legal interpretation).

These Regulations give effect to Commission Implementing Regulation (EU) No. 433/2011 of 4 May 2011 amending Annex 1 to Regulation (EC) No. 669/2009 implementing Regulation (EC) No. 882/2004 of the European Parliament and of the Council as regards the increased level of official controls on imports of certain feed and food of non-animal origin.

These Regulations amend the European Communities (Official Controls on the Import of Food of Non-Animal Origin) Regulations 2010 (S.I. No. 391 of 2010) in the manner specified in these Regulations.

These Regulations revoke the European Communities (Official Controls on the Import of Food of Non-Animal Origin) (Amendment) Regulations 2011 (S.I. No. 131 of 2011).

These Regulations may be cited as the European Communities (Official Controls on the Import of Food of Non-Animal Origin) (Amendment) (No. 2) Regulations 2011.
