EUROPEAN COMMUNITIES (MINIMUM CONDITIONS FOR EXAMINING AGRICULTURE PLANT SPECIES) (AMENDMENT) REGULATIONS 2012

- I, SIMON COVENEY, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Implementing Directive 2012/8/EU of 2 March 2012¹, hereby make the following regulations:
- 1. These Regulations may be cited as the European Communities (Minimum Conditions for Examining Agriculture Plant Species) (Amendment) Regulations 2012.
- 2. The European Communities (Minimum Conditions for Examining Agriculture Plant Species) Regulations 2004 (S.I. No. 122 of 2004) are amended by substituting in Regulation 2 the definition of "Directive" for the following-
- "Directive' means Commission Directive No. 2003/90/EC of 6 October 2003² as amended by Commission Directive No. 2012/8/EU of 2 March 2012."
- 3. The European Communities (Minimum Conditions for Examining Agriculture Plant Species) (Amendment) Regulations 2011 (S.I. No. 738 of 2011) is revoked.
