## EUROPEAN COMMUNITIES (OFFICIAL CONTROLS ON THE IMPORT OF FOOD OF NON-ANIMAL ORIGIN FOR PESTICIDE RESIDUES) (AMENDMENT) REGULATIONS 2014.

- I, SIMON COVENEY, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Implementing Regulation (EU) No 1355/2013 of 17 December 2013<sup>1</sup>, hereby make the following regulations:
- 1. These Regulations may be cited as the European Communities (Official Controls on the Import of Food of Non-Animal Origin for Pesticide Residues) (Amendment) Regulations 2014.
- 2. The European Communities (Official Controls on the Import of Food of Non-Animal Origin for Pesticide Residues) Regulations 2011 (S.I. No. 426 of 2011) are amended by substituting in Regulation 2(1) for the definition of "Commission Regulation 669/2009" the following—
  - "'Commission Regulation 669/2009' means Commission Regulation (EC) No. 669/2009 of 24 July 2009<sup>2</sup> as amended by Commission Regulation (EU) No. 212/2010 of 12 March 2010<sup>3</sup>, Commission Implementing Regulation (EU) No 91/2013 of 31 January 2013<sup>4</sup> and Commission Implementing Regulation (EU) No 1355/2013 of 17 December 2013;".
- 3. The European Communities (Official Controls on the Import of Food of Non-Animal Origin for Pesticide Residues) (Amendment) (No.4) Regulations 2013 (S.I. No. 408 of 2013) are revoked.
