## EUROPEAN UNION (RECOGNITION OF PROFESSIONAL QUALIFICATIONS) (DIRECTIVE 2005/36/EC) (AMENDMENT) REGULATIONS 2014

- I, JAN O'SULLIVAN, Minister for Education and Skills, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) and for the purpose of giving further effect to Directive 2005/36/EC of the European Parliament and of the Council of 7 September 2005<sup>1</sup>, as amended by Council Directive 2006/100/EC of 20 November 2006<sup>2</sup>, Commission Regulation (EC) No. 1430/2007 of 5 December 2007<sup>3</sup>, Commission Regulation (EC) No. 755/2008 of 31 July 2008<sup>4</sup>, Regulation (EC) No. 1137/2008 of the European Parliament and of the Council of 22 October 2008<sup>5</sup>, Commission Regulation (EC) No. 279/2009 of 6 April 2009<sup>6</sup>, Commission Regulation (EU) No. 213/2011 of 3 March 2011<sup>7</sup>, the Treaty concerning the accession of the Republic of Croatia to the European Union done at Brussels on the 9th day of December 2011<sup>8</sup>, Commission Regulation (EU) No. 623/2012 of 11 July 2012<sup>9</sup> and Council Directive 2013/25/EU of 13 May 2013<sup>10</sup>, hereby make the following regulations:
- 1. These Regulations may be cited as the European Union (Recognition of Professional Qualifications) (Directive 2005/36/EC) (Amendment) Regulations 2014.
- 2. The Recognition of Professional Qualifications (Directive 2005/36/EC) Regulations 2008 (S.I. No. 139 of 2008) are amended—
  - (a) in Regulation 2—
    - (i) by substituting the following for the definition of "the Directive" in paragraph (1):
      - "'Directive' means Directive 2005/36/EC of the European Parliament and of the Council of 7 September 2005<sup>1</sup>, as amended by Council Directive 2006/100/EC of 20 November 2006<sup>2</sup>, Commission Regulation (EC) No. 1430/2007 of 5 December 2007<sup>3</sup>, Commission Regulation (EC) No. 755/2008 of 31 July 2008<sup>4</sup>,

- (ii) by revoking paragraph (6), and
- (b) in Regulation 4—
  - (i) by deleting ", as updated by 2006/100/EC in respect of professional qualifications in Bulgaria and Romania" in subparagraph (a), and
  - (ii) by deleting ", as updated by 2006/100/EC in respect of professional qualifications in Bulgaria and Romania" in subparagraph (b).
