## EUROPEAN COMMUNITIES (OFFICIAL CONTROLS ON THE IMPORT OF FOOD OF NON-ANIMAL ORIGIN FOR PESTICIDE RESIDUES) (AMENDMENT) (NO. 4) REGULATIONS 2014.

I, SIMON COVENEY, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Implementing Regulation (EU) No 885/2014 of 13 August 2014<sup>1</sup> and Commission Implementing Regulation (EU) No 1021/2014 of 26 September 2014<sup>2</sup>, hereby make the following regulations:

1. These Regulations may be cited as the European Communities (Official Controls on the Import of Food of Non-Animal Origin for Pesticide Residues) (Amendment) (No.4) Regulations 2014.

2. The European Communities (Official Controls on the Import of Food of Non-Animal Origin for Pesticide Residues) Regulations 2011 (S.I. No. 426 of 2011) are amended by substituting—

(a) in Regulation 2(1) for the definition of "Commission Regulation 669/2009" the following—

" 'Commission Regulation 669/2009' means Commission Regulation (EC) No. 669/2009 of 24 July 2009<sup>3</sup> as amended by Commission Regulation (EU) No. 212/2010 of 12 March 2010<sup>4</sup>, Commission Implementing Regulation (EU) No 323/2014 of 28 March 2014<sup>5</sup>, Commission Implementing Regulation (EU) No 718/2014 of 27 June 2014<sup>6</sup> and Commission Implementing Regulation (EU) No 1021/2014 of 26 September 2014 and Commission Regulation (EU) No. 885/2014 of 13 August 2014;", and

- (b) Regulation 12(2)(o) for the following—
  - "(*o*) provides misleading information in relation to a proposed re-dispatch of a consignment in accordance with Article 21 of EC Regulation 882/2004;
