## EUROPEAN UNION (RECOGNITION OF PROFESSIONAL QUALIFICATIONS) (AMENDMENT OF BUILDING CONTROL ACT 2007) REGULATIONS 2014

I, ALAN KELLY, Minister for the Environment, Community and Local Government, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) and for the purpose of giving further effect to Directive 2005/36/EC of the European Parliament and of the Council of 7 September 2005<sup>1</sup>, as amended by Council Directive 2006/100/EC of 20 November 2006<sup>2</sup>, Commission Regulation (EC) No. 1430/2007 of 5 December 2007<sup>3</sup>, Commission Regulation (EC) No. 755/2008 of 31 July 2008<sup>4</sup>, Regulation (EC) No. 1137/2008 of the European Parliament and of the Council of 22 October 2008<sup>5</sup>, Commission Regulation (EC) No. 279/2009 of 6 April 2009<sup>6</sup>, Commission Regulation (EU) No. 213/2011 of 3 March 2011<sup>7</sup>, the Treaty concerning the accession of the Republic of Croatia to the European Union done at Brussels on the 9th day of December 2011<sup>8</sup>, Commission Regulation (EU) No. 623/2012 of 11 July 2012<sup>9</sup> and Council Directive 2013/25/EU of 13 May 2013<sup>10</sup>, hereby make the following regulations:

1. These Regulations may be cited as the European Union (Recognition of Professional Qualifications) (Amendment of Building Control Act 2007) Regulations 2014.

2. Section 2 of the Building Control Act 2007 (No. 21 of 2007) is amended, in subsection (1), by the substitution of the following for the definition of "Directive":

" 'Directive' means Directive 2005/36/EC of the European Parliament and of the Council of 7 September 2005<sup>1</sup>, as amended by Council Directive 2006/100/EC of 20 November 2006<sup>2</sup>, Commission Regulation (EC) No. 1430/2007 of 5 December 2007<sup>3</sup>, Commission Regulation (EC) No. 755/2008 of 31 July 2008<sup>4</sup>, Regulation (EC) No. 1137/2008 of the European Parliament and of the Council of 22 October 2008<sup>5</sup>, Commission Regulation (EC) No. 279/2009 of 6 April 2009<sup>6</sup>, Commission Regulation (EU) No. 213/2011 of 3 March 2011<sup>7</sup>, the Treaty concerning the accession of the Republic of Croatia to the European Union done at Brussels on the 9th day of
